In addition all kosher trailers shall have a numbered kosher seal from the Florida K attached to the rear opening of the trailer.

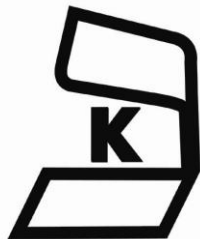
